The meeting was called to order at 4:00 pm

Agenda – The agenda was amended to add warning of a public meeting on February 2, 2015 on the Town's capital plan.

Magna Dodge moved, Bruce Hiland seconded, a motion that the Town warn a public hearing on February 2, 2015 to consider the Town's capital plan. The motion was unanimously approved.

Ben Marks then moved, and Bruce Hiland seconded a motion to go into executive session to discuss negotiations with VGS. The motion was unanimously approved.

Mary Martin asked whether there would be an opportunity for public comment before the Select Board went into executive session.

In order to receive public comment, Ben Marks moved, Bruce Hiland seconded, to rescind the motion to go into executive session. The motion was unanimously approved.

Public Comment:

Randy Martin asked what the Board would be talking about in executive session. Ben M. responded that the Board would be getting legal advice related to its negotiations with Vermont Gas.

Mary Martin indicated that she was confused whether Ben M. was acting as the Select Board's attorney or as a Select Board member and would like the Select Board to be more clear about Ben M's role. Ben Wood responded that once in executive session, Ben M. would be acting as the Select Board's attorney. There was a short discussion of how to make Ben M.'s role clear in future meetings.

Raph Worrick asked whether VGS had asked that a vote of citizens be taken before town meeting. Ben M. responded "no."

Mary Martin asked how long the Select Board would be in executive session. Ben Wood and Dave Sears responded that the Select Board would act as efficiently as possible.

Randy Martin asked whether the Select Board would be taking any action after the executive session. Ben M. explained that as the date for posting notice for the February 12, 2015 special public meeting had been missed, in order to have a special meeting of the Town on another date, the Board would have to set a new select board meeting with the issue of a new public meeting date specifically warned.

David Sears moved, Bruce Hiland seconded, to find that premature general public knowledge of the town's negotiations with Vermont Gas would clearly place the selectboard at a substantial disadvantage, because the selectboard would risk disclosing its negotiation strategy if it discusses its negotiations in public and that that we enter into executive session to discuss the same under the provisions of Title 1, Section 313(a)(1)(A) of the Vermont Statutes. The motion passed unanimously.

The Board entered executive session at 4:20

The Board exited executive session at 4:50.

Magna Dodge moved, Bruce Hiland seconded, to adjourn. The motion passed unanimously.
