- **Common Level of Appraisal** Report from PVR Dept of Taxes that Cornwall's common level of appraisal has increased to 98.04

- *CVFD West Cornwall Project Update*: Dave Berno and Dennis Rheaume updated the board on progress and challenges of the Fire Department's efforts to obtain/maintain needed equipment and suitable housing for it. New State mandates have greatly increased projected costs for the building project in West Cornwall. Priority: a new utility truck (which is in capital budget) and suitable housing for it. Fire Department will submit Article for the Town Meeting warning. Dave Sears will call VLCT to determine if there needs to be a town vote to transfer the land to the Fire Dept.
- **Town Garage Sodium Chloride Issue** Dave Anderson sent a report with a list of recommendations from Helen Mango. Bruce will follow up with Dave to clarify.
- Budget Development working session on FY 2013 budget. If final numbers are not ready by January 17, there will be a special meeting of the board the following week to approve the budget.
