## **MINUTES**

### CORRESPONDENCE REVIEW

Report from the Vermont Department of Taxes stating that Cornwall's common level of appraisal is 96.44% and coefficient of dispersion is 8.14. Sue J. said this is good news for Cornwall.

### **NEW BUSINESS**

**Animal Control Officer Request** – Mike Q. reported that Bruce Payne would like the ordinance change to "dogs only". Apparently Bruce P. is being called by the State Police for to deal with problems with cows and Bruce said has no place

to keep cows. Actually, Cornwall has just a dog ordinance and it is the job of the Animal Control Office to enforce the dog ordinance, not to deal with other animals, so it is already "dogs only." Sue J. said that in former years, Cornwall had a pound keeper who would keep larger animals like cows in a stockade, identifying the owner of the cow by the earmark. Cornwall no longer has anyone who serves as pound keeper. Mike will inform Bruce Payne, on how he can respond, if called upon to deal with problem cows again. Bruce Hiland will ask Secretary of State's Office to clarify municipal responsibility on this issue.

## OTHER BUSINESS

- **Selectboard openings** Two positions are coming open on the Selectboard for March elections. Sue J. will inform people in the newsletter. Bruce H. asked the board to generate a list of names, encourage interested persons to visit a meeting, and give anyone who is interested a copy of the petition.
- **Town of Weybridge** Weybridge Selectboard would like to meet with Cornwall Selectboard, to talk about sharing jobs and/or equipment, suggested January 4. which conflicts with Cornwall regular meeting, which has full agenda. Bruce will get back to them, suggest they come here on another date in Januaury for an afternoon meeting.
- LFICD Appointment Mike MOVED, Judy SECONDED to appoint Bob Gerlin to the Lemon Fair Insect Control District, retroactive to ,,June 1, 2010
