Old and New Business:

- 1) Swamp Reclassification project discussed 3 Steering meetings. Some of Salisbury landowners are concerned and opposed. Cornwall will consider phases for information-gathering. Americorps interns are available to assist.
- Beaver Brook Headwaters Walk Sat. Nov. 2, 12:30 -2:30 pm, led by Craig Zondag and will focus on disturbed habitat, habitat through history, birds, woods and beavers.
- 3) DRB Cheetham application. CCC has some concerns on the sub-division's impact on wildlife and will submit them. Also discussed BBP.
- 4) Derrick Burt, from MALT came to discuss our goals. He's a Middlebury College senior, and interning at MALT, talking about the Strategic Plan, looking at and adding to data. 182,000 acres are protected in Addison County: GMF is 40%, VLT is 40%, MALT is 2%. He's made a webmap, which may be available through MALT. The highest priority is undeveloped forest blocks, as well as surface waters and riparian areas.
- 5) "Summer Migrants Cornwall Birds" Spring Presentation and Walk, which will include grasslands and forest margins. Date TBD.
- 6) Conservation Summit the theme is "Investing in Vermont's Conservation Future: Vermont Conservation Design". These summits are always very interesting and informative, with many opportunities to meet and connect with others across the state! It is also VERY close – up at the Breadloaf campus, during Fall Foliage, and open to everyone. Sat. Sept. 28, from 8:30 a.m. – 3:30 pm. Carpooling is encouraged. Registration through VT Conservation Commission's 2019 Conservation Summit.
- 7) Public Comments for Public Land Management deadline is Aug. 26th, to keep our lands public vs. open for drilling, mining and logging.

- 8) CPC meeting, Aug. 21st. discussing SFO for the Zoning regs. Ben Marks will be sharing the SB's next steps for the Zoning regs. MD will attend.
- 9) Outreach: MS will contact the new principal at Cornwall School. MS will review and update CC website, KB will refresh the Town Hall Display Board.
