TOWN PLAN UPDATE – continued

Review of Energy Section

The board and Kevin Lehman discussed overall progress in Town Plan update. Kevin made the following suggestions about important issues, goals and strategies to include in the Energy section of the updatedTown Plan.

Highest priority:

- 1. Create a Cornwall Energy Committee (to get PACE program going, do outreach)
- 2. Create 1-3 energy goals
- 3. Link goals to strategies and concrete actions
- 4. Add information on energy financing programs, such as PACE, CVOEO, and NWWVT
- 5. Link energy with land use
- 6. Update information so it is current (two excellent resources: new Vermont Comprehensive Energy Plan and the Renewable Energy Atlas)

Lower priority:

- 1. Add information about fuel assistance program
- 2. Add information about rebates and incentives and the services of Efficiency Vermont

Goal Suggestions:

- 1. Improve energy efficiency of existing housing stock
- 2. Encourage energy efficiency in new construction
- 3. Encourage renewables for homes and businesses
- 4. Transportation and land use links

Possible strategies:

- Partner with groups such as Efficiency Vermont, VPIRG, ACRPC, and Acorn Energy CoOp (for education, energy programs, technical assistance, buying programs)
- 2. Energy Code
- 3. PACE

Other ideas:

- 1. ZA should have a handout for folks doing remodels about energy
- 2. Promote "energy smart" site orientation
- 3. State has energy code, no other state or local building codes
- 4. CPC will ask Energy Coordinator Gary Barnett to review drafted energy section.

It was noted that the organization known as Smartgrowth Vermont is now folded into the Vermont Natural Resources Coundeil (VNRC).
