Regular Meeting, Cornwall Town Hall March 19, 2017

The meeting was called to order by Town Clerk Sue Johnson at 7:07 pm. Quorum - established.

TOWN CLERK / TOWN TREASURER'S REPORT - Sue Johnson

- Annual Financial Report Sue J. provided copies of the draft of the financial report by the auditors to the Board.
- Lawn Mowing Bids the time has come to solicit bids. Sue will proceed with this task.
- Archival Records Sue J. showed the Board the oversized book that now holds the Grand List from 1882-1889. As required by State law, Cornwall is making sure that such records are preserved for all time. This book holds original Grand List pages in archival sleeves, that can be photographed without removing from the sleeve.
- Book Storage Sue expressed concern about lack of accessible storage space for book sale donations as they are received from March until the sale in the fall. Losing book storage space was an unexpected outcome of the Town Hall renovation. Options to solve the problem include adding a storage shed or improving the walkway to the basement. Sue J. will research and bring more information back to the Board.

ROAD COMMISSIONER / ROAD FOREMAN'S REPORT - Brian Kemp and Michael Sunderland

• Swamp Bridge New Sign - Michael S. reported that the bridge on Swamp Road now has a sign on Cornwall side (as well as Salisbury side) for "No Through Trucks" as specified in the road ordinance.

- Road Conditions Michael S. discussed with the board the condition of some places on gravel roads in Cornwall that have turned to "soup" as result of recent weather, causing vehicles to become stuck. This is a problem statewide. Adding coarse stone has helped in the short term. Brian K. has drafted a paragraph for the newsletter explaining the road situation and asking for the public's patience, until conditions making grading possible again.
- Mower Bid Michael S. has gotten a second bid for the mower as requested.
 The Capital Committee will meet and review the plan.
- Damage to Sand Shed Wall recent damage has occurred, which can be repaired. Plan to replace the sand shed should be reviewed, as life of the structure is limited.
- · Discuss Paving Memo from Stu Johnson tabled until the April meeting.

OLD BUSINESS

- Sperry Road Dog Bite Incident discussion Ben M. met with the dog owners, who have proposed fencing and a tethered dog run with steel cord. Board discussed the issue. Ben M. will draft a letter to the owners for the Board to review.
- Update on CVFD Radio Tower petition Ben M. reported that the experts have made assessments, as required by the Public Utilities Commission. The updated application will be submitted next week.
- Update on Rosenberg dog issue the Board discussed the dog owner's response to reports of the dog's continued road roaming, creating a risk for drivers. Ben will write another letter informing the owners that if there is another incident, the Board will call a hearing.
- Dog Bite on West Street John R. heard from a West Street resident that a
 dog bit her fingers while she was walking on West Street, with no apparent
 injury. At this point, she does not wish to make a formal complaint.
- Peet Tax Appeal Settlement After short discussion, John R. MOVED / Brian K. SECONDED a motion to accept the Peet Tax Appeal Settlement. Motion passed - 4 in favor, 0 opposed.

- Justice of the Peace position -John R. MOVED / Magna D. SECONDED a
 motion that the Board request to the Governor that Marge Drexler be
 appointed to the vacant Justice of the Peace position. Motion passed 4 in
 favor, 0 opposed.
- Approval of permit for special event John R. MOVED/ Magna D.
 SECONDED a motion to ratify the approval of a special event permit for a March 15-16 event on Cider Mill Road. Motion passed - 4 in favor, 0 opposed.
- Delegating authority to approve special event permits Brian K. MOVED / Magna D. SECONDED a motion to delegate authority to the Chair or the Vice Chair to direct the Town Clerk to sign permits for special events. Motion passed - 4 in favor, 0 opposed.
