Fire Department Key Access Boxes (Knox Box) Information

The Cornwall Volunteer Fire Department encourages property owners who have automatic alarm systems to consider installing a key access box to allow us to enter your building without property damage in the case of a fire alarm. These boxes are installed in a location of your choosing to give the department access to keys and can also store information sheets that can help us with questions about entry and alarm and electrical systems which can assist in our response. The department holds a master key to these boxes which is accessible only to our responders. We utilize a system made by the Knox company. To order one of these online, follow the instructions below. Go to knoxbox.com Click one of the "BUY" buttons (there are several on the page)

On the dropdown menu on the next page, select Vermont in the first window. Then start typing in "Cornwall" and Cornwall Vol Fire Dept will appear in the next window. Click the "Select Department" button. This will take you to the product order page and ensure that the box is keyed correctly for our access.

Most people will likely want the residential model which can be found by scrolling down the page (its near the bottom below the red "remote power" box). Larger commercial boxes are available for locations with multiple access points.

Once the box is delivered, the purchaser needs to contact the fire department (they can call Raph Worrick at 989-2568) and we will complete the installation with them.

News from Fire Warden Tommy Frankovic Jr.



The 2019 Fire Season continues to go smoothly. The majority of forecasts this year for Addison County saw mostly low ratings of fire danger from the Vermont Department of Forests, Parks, and Recreation, with only a few days of moderate fire danger due to higher air temperature, low humidity, or high winds.

So far this season, we are approaching 160 issued burn permits to date, which has surpassed the number issued in 2018. Again, I would like to thank the residents of Cornwall for reaching out to me with all of your questions regarding burn permitting, what is acceptable material that can be burned, as well as

sending me pictures of what you are planning to burn. I have even received calls/texts from some of who have decided to postpone your burn on days that turned out to be too warm or breezy for a safe burn. This is a fantastic proactive approach to ensuring Wildland Fire Safety. Thank you all!

Just a reminder that 2020 will be a major election year for Vermont and the USA. If you are not registered to vote, there are many options for getting that done. You can stop by the Town Hall and register, call and ask for a registration form to be mailed, register online at MyVoterPage.com or register when you renew your driver's license. Absentee/Early Voting will be available for each of the 4 elections to be held next year. Federal election ballots need to be ready 45 days ahead of any election, so you can check in with me if you are interested in voting that way. You can also request an early ballot online as well. The three federal elections next year will be the Presidential Primary on March 3, 2020, the State Primary on August 11, 2020 and the General Election on November 3, 2020. Town Officials Australian ballot voting will also take place on March 3, 2020.

Vermont 9-1-1 Launches CARE Program

Citizens Assistance Registry for Emergencies Montpelier, Vermont – September 9, 2019

Those who need special assistance during a disaster or evacuation can alert local responders of that need before emergencies. The CARE (Citizens Assistance Registry for Emergencies) program allows the elderly, people with limited mobility, or those who require specialized medical equipment to get extra help during a disaster.

Local officials can provide special assistance to those who face unique challenges during evacuations, power outages, or extended periods of isolation. For those who have registered, CARE allows local emergency responders access to their information so they can better help these individuals during an evacuation, power outage or similar event.

CARE grew out of a partnership of statewide non-profits and government agencies. Following Tropical Storm Irene, the project gained momentum and launched its pilot in Lamoille County, thanks to the leadership and support of Sheriff Roger Marcoux of the Lamoille County Sheriff's Department. CARE's key partners are the United Way of Vermont, Vermont 211, Vermont Emergency Management, and Vermont 911. The program is a voluntary database for which users register using their preferred contact information.

Online registration is available at e911.vermont.gov/care. When registration is complete, submitted information is entered into a database linked to the Vermont 911 system. All records are confidential and will only be shared with responders involved in helping to keep people safe in an emergency. Please be aware that it is up to emergency response agencies to decide whether and when to use CARE information. Citizens must remember that they are responsible for calling 911 if they feel they are in danger at any time.

If you, or someone you know, like a grandparent, or parent, would need special help in a wide-scale event, please visit the website for more information and to register. A hard copy of the form to print and mail is also available on the site.

Linguistics Request!

My name is Stephen Howe. I am an associate professor of historical linguistics in Japan but was born in England. I am researching special words for "no" and "yes" in Vermont. Colonists from the East of England, where I grew up, may have brought "dow" and "jearse" to New England in the seventeenth century. Four hundred years later, these special words still survive.

Gerald E. Lewis gives an example of "daow" in *How to Talk Yankee*:

Did you get your deer yet?

Daow, I can't even see one.

And an informant from New Hampshire gives an example of "jearse," stating that "I totally just thought this was a weird NH thing":

Hey, have you seen where the muffin tins went? Hmmm, jearse, in the oven I think.

In the East of England, we still use "dow" and "jearse" today.

However, these words for "no" and "yes" are not recorded in the Oxford English Dictionary or the Survey of English Dialects. Nor were they recorded by the Linguistic Atlas of New England; but the Dictionary of American Regional English cites daow, daowd, dow, doh or day-oh in Maine, Vermont, Massachusetts and Rhode Island as well as New York State. There is also daow in New Hampshire. For "jearse," informants in my survey cited jass in Upstate New York and possibly Vermont, jearse in New Hampshire, and jyes or djess in Maine and Massachusetts.

I am writing a book on "jearse" and "dow" and wonder whether it might be possible to ask your residents whether they know either of these words? I would be most grateful for any information you may have. I have more information about my research plus a survey that readers can complete online at <http://yesandno.info/>

Conservation Commission News

Nature Walk on Saturday, November 2nd

How Our Lands Reflect Natural and Human History. 12:30 – 2:30 pm. Cornwall Orchards B&B, 1364 Route 30, Cornwall

Join field biologist Craig Zondag and innkeepers Lise Anderson and Miles Peterle for a fascinating stroll highlighting how different historical, human, farming and natural activities leave their distinctive marks on a particular parcel of land. The 13 acres surrounding Cornwall Orchards B&B (built in 1793) are a microcosm of the history of Cornwall itself over the centuries. On this walk, we can expect to see a beaver dam, vole tunnels, one of the several headwater sources of Beaver Brook and one of the last remaining stands of the Witherell family's orchard which was planted in 1910.

Parking: Park by the barn. Parking is limited, so please carpool from Cornwall Town Hall or the Fire Station. Parking is illegal along the side of Route 30. There is a small pull-off at the corner of Route 30 and Ridge Road, if parking is full at the B&B. For more information, please contact CCC member Katherine Branch. No dogs or other pets please. Wearing waterproof or rubber boots is advisable.

Update on Otter Creek Wetland Reclassification. Members of the Cornwall Conservation Commission continue to serve on the Otter Creek Wetlands Steering Committee. The Otter Creek Wetlands are a complex of swamps along Otter Creek that provide a remarkable array of community benefits in the form of water quality, flood mitigation and wildlife habitat. In pursuing Class 1 designation for wetland parcels, the Committee is working with willing landowners who support this effort. Reclassification as a Class I wetland would officially recognize the many public benefits of this ecologically rich wetland complex and the role it has in supporting our everyday lives. The Steering Committee has begun to reach out to landowners to determine their level of interest and support and will be mapping areas in Cornwall that will be nominated for Class 1 wetlands sta-

Conservation Commission and citizen input at June Cornwall Land Use and Development Regulations hearing.

The Conservation Commission submitted oral and written testimony at the June 27th Cornwall Select Board hearing on the March 2019 draft of the Land Use and Development Regulations (LUDR) document which will govern zoning and subdivision proposals in the Town. The Conservation Commission requested that the current March 2019 draft be amended so as to ensure that there is adequate guidance and review in the minor subdivision application process for consideration of ecological significant sites, interior forest and habitat connectivity blocks. In the prior January 2019 draft of the LUDR document, these considerations applied to all development in the Town of Cornwall: minor subdivisions of up to 3 lots, major subdivisions, PUDs and variances. In the March draft, minor subdivisions were excluded from this ecologically-related consideration and no explanation was given in the draft for the exclusion, nor was there clear language elsewhere in the document to guide minor subdivision applicants in how to meet LUDR document's Statement of Intent (102.1.c): that development "preserve the natural ecology of the town and protect native and resident plant and animal species by considering the impact of land development on their environment." Among the Cornwall citizens making comments at the Select Board meeting, there was wide-spread concern that minor subdivisions are not being subject to specific ecological review in this new draft.

Commission chairperson wins conservation award.

On September 7th, CCC chairperson Mary Dodge won the Vermont Coverts David Clarkson award for Outstanding Cooperator in the state. The mission of Vermont Coverts is to enlist Vermont landowners in a long-term commitment to maintain and enhance diverse wildlife habitat and healthy ecosystems and the

David Clarkson award recognizes the person who through action on their own land, within the Coverts network, and within their communities exemplifies the Coverts mission.

Association of Vermont Conservation Commissions (AVCC) summit in Ripton September 28th. Several CCC members attended the annual summit meeting of the AVCC which featured talks and working sessions on the history of conservation planning in Vermont, how land conservation preserves community value, and how specialized maps can help guide bird conservation efforts.

The Commission meets about once a month and provides advice and recommendations to the Select Board, the Planning Commission, the Developmental Review Board, and town residents regarding natural resources, including important agricultural, recreational and scenic resources. Planning Commission News

Greetings Cornwall!

Since we last shared news, the Planning Commission has been hard at work drafting language to amend the Town Plan with a new section covering Flood Resilience. Since 2014, the State of Vermont has asked that towns address the concerns around flooding and fluvial erosion in their towns to better contend with this dynamic force of nature.

As mentioned in our summertime missive, the Town of Cornwall has done a good deal of work to consider and plan against flooding, erosion, and of particular concern in our town handle storm-water runoff with amendments to roadways and culvert replacements. Our current draft recognizes the good work that has been done and lays out some options for a path forward. It is our hope to hold a hearing in the coming months to discuss the topic with our neighbors and hear what they have to say. Once we're confident the draft best reflects the situation and offers thoughtful actions that the Town can reasonably accomplish, we'll share it with the town. Please keep your eyes peeled!

Depending on the publication date of this newsletter, the Planning Commission will have met or will shortly be meeting in a joint session with the Selectboard to discuss the draft of the Land Use and Development Regulations. The project of revising and updating the Zoning and Subdevelopment regulations has been a large and long project. From a procedural standpoint, there is a one year "deadline" for the approval process. If no official action by the Selectboard takes place on the proposed draft by the first week of March 2020, it will be considered disapproved. Despite this timeframe, the Planning Commission is committed to the project and hopes for a fruitful and productive end to the process.

There are a number of opportunities to get involved in town, both on the Planning Commission, the Emergency Planning Committee, and more! Vermont town government is sustained with the energies and efforts of the citizens that populate its municipalities and Cornwall is no different. If you find yourself wondering more about how the town functions, please feel free to stop into a Planning Commission meeting to see how our business is conducted. If your interest extends further, any of our members would be happy to talk with you about getting involved.
