**AGENDA** - John R. MOVED / Brian K. SECONDED a motion to approve the agenda as amended with corrected date of November 19 minutes to approve. Motion passed - 5 in favor, 0 opposed.

**MINUTES**

- **November 19, 2019** - Magna D. MOVED / Ben W. seconded a motion to approve the minutes as thus amended. Paragraph under Land Use Regulations to read:

**NEW BUSINESS**

- **First Review of 2020/2021 Town Budget** - Town Clerk/Town Treasurer and the Select Board reviewed the draft General Fund Budget. Significant increase in office expenses are being caused by increase in costs for cybersecurity.
- **Discussion of Capital Budget and Hearing Date**- John R. MOVED / Ben W. SECONDED a motion to set the hearing date as January 7, 2020. Motion passed - 5 in favor, 0 opposed.

**OTHER BUSINESS** - Ben M. reported that he received a call from Brett at the Sheriff's Department, who shared information that relates to the Town budget. The Board will discuss further during budget preparation at next meetings.

John R. MOVED / Magna. SECONDED a motion to adjourn the meeting. The motion passed - 5 in favor, 0 opposed.
