**AGENDA** - Marge D. MOVED / Lauren R. SECONDED a motion to approve the agenda as posted. Motion passed - 6 in favor, 0 opposed.

#### **MINUTES**

CORRESPONDENCE REVIEW - none

PUBLIC COMMENTS - Katherine Branch and Mary Dodge, members of the Cornwall Conservation Commission (CCC) presented an overview of the history, scope, and activities of the CCC, including a recent investigation into how area towns fund their conservation funds. Cornwall has a dedicated fund and a checking account, and now needs to obtain funds. The CCC plans to present an Article at Town Meeting proposing an appropriation, which is how the majority of towns obtain such funds. Katherine B. and Mary D. pointed out that the work of the CCC and the CPC has frequently been collaborative, as Town planning and conservation issues often intersect. They also mentioned that the Town website has information about conservation resources that may be of interest, especially to new CPC members.

#### **OLD BUSINESS**

• Outreach Review - The Board discussed some options for outreach, including social media, press releases, writing articles for the Addison Independent when newsworthy things happen, and taking advantage of times when people congregate (such as recent outdoor concert series in Cornwall). Conor S. said there was a

miscommunication with Bas about when to investigate how other planning commissions do outreach, so no report tonight, but he will follow up with Bas. Conor S. suggested that a communications and outreach work group would be helpful at this time - Marge D., Lauren R. and Chris H. volunteered.

- Childcare Forum AJ presented information about the virtual childcare forum she attended. She said it was very informative. The current situation in Vermont regarding insufficient child care slots and high cost of child care (for example an average of 30% of a family's income is spent in child care costs) is discouraging, but what she heard in the forum is that there is a lot of interest in making it better. The Town Plan update needs to include an updated section on child care issues. Geographic area for resources needs to include Middlebury.
- **Zoning Update** Conor S. and Don B. have prepared a set of 8 annotated documents as background and resource information for new members. AJ suggested a shared folder on Google Drive as a way to make readily available to all.

### **NEW BUSINESS**

- Planning Manual Discussion- highlights of the discussion included the value of the
  checklist of State planning goals, the question of how to engage citizens so they feel
  they have a voice in development of Town regulations and the Town Plan, and the
  importance of basic information that addresses the question of why does a Town even
  need a Town Plan? Going forward, it was agreed that having a timeline and assigning
  clear responsibilities or planning tasks is the key to success.
- **Town Plan Discussion -** Members shared their impressions of the first 30 pages of the Town Plan, their enthusiasm about the data and curiosity about what updated census and other data will say about Cornwall today. At the next meeting, the next 30 pages will be discussed.

### **OTHER BUSINESS**

**Potential New Member -** Drew Kervick introduced himself and spoke about his background, interest and enthusiasm for joining the CPC. After discussion, Don B. MOVED / Marge D. SECONDED a motion to recommend that the Select Board appoint Drew Kervick to Planning Commission. Motion passed - 6 in favor, 0 opposed.

# **List of Action Items:**

- 1. CPC communications and outreach work group (Chris H., Lauren R. and Marge D.) will look into opportunities and will give a brief report at the next meeting.
- 2. Conor S. will establish a CPC folder on Google Drive and share the 8 documents in Google Doc format and will invite CPC members to view and contribute. Members should read these over the next 2-3 months to get up to speed on the current work of the CPC.
- 3. AJ will add the memo about child care resources to the CPC folder on Google Drive.
- 4. Conor S. will reach out to Bas about progress in contacting other planning commissions about outreach.
- 5. Members should read the next 30 pages of the Town Plan (through "Cornwall Today") for discussion at the next meeting.

- 6. Conor S. will contact the Select Board with the recommendation to appoint Drew K. to the CPC.
