#### Old Business:

1) CC Blog. Andrea had sent out a Blog status summary and posting tips prior to the meeting. Mike will review before she sends them to the Cornwall school teachers. Kristina work with Andrea on the blog. Blog posts can also be put up on Instagram and Facebook, and Kristina has the skills to do this. A Midd College student has been working on the blog, helping with setting it up. There is the potential to have Mary Hogan elementary school students do some blog posting, and Mike is following up with that possibility. Kristina has set up a "generic" email for the CCC, so that individual email addresses do not have to be used—it will be posted on the blog.

c. Trail Camera. Mary said that a new iNaturalist site (*Cornwall Vermont Selected Wildlife Observations*) has been set up to archive the observations of fur-bearing predators from the project's trail cameras. Residents can add also add their photos to the site, if they have been taken after the project started in March of 2020.

Regarding sponsorship, Katherine suggested that having information about an organization before deciding on sponsorship is important and suggested the CC develop a short list of requested information from the sponsor would be helpful.
