CORRESPONDENCE REVIEW

- Notice from Town Attorney's office regarding rates and policies for the coming year - requires a signature to continue with this firm. Brian K. MOVED / Tanya B. SECONDED a motion to authorize the Chair to sign where indicated and return. **Motion passed** - 5 in favor, 0 opposed.
- Letter from Eric Mortenson about the missing road sign at the corner of Douglas Road and Route 30. Steven R. will follow up on replacing it. Steven R. added that he has also received requests for signs with numbers and arrows at intersections. These types of signs can save critical time, aiding emergency responders in choosing to turn right or left at intersections to reach a specific address. Steven and Ben M. will working on this issue in the next couple of weeks, to determine how many such signs are needed, dimensions, height, etc. It was suggested that America Rescue Plan Act (ARPA) funds could be used to pay for these signs.
- Reminder from Addison County Solid Waste Management District that Cornwall needs to appoint a representative. John R. said he will post a notice on Front Porch Forum in hopes that someone from Cornwall will step forward.
- Latest sodium report - sodium levels remain high but are expected to decrease when pumps are operational again after the water in the lines is not frozen.
- Email message from Susan Whitmore requesting ARPA funds for John Graham Shelter.
- Request from Beth Karnes Keefe for permission to place a grant funded planter box outside the Town Hall for pollinator friendly plants. Tanya B. will follow up with Beth K.-K. for more details.
- Letter from New England Regional Resource Center (NEMRC) offering an in-depth analysis of the annual audit, for a fee.
- Hard copy of the latest Addison County Regional Plan now available in the office
- Reminder that the Local Emergency Management Plan (LEMP) is due by May 1

PUBLIC COMMENTS - none

TOWN CLERK / TOWN TREASURER'S REPORT - Sue Johnson

- Election process was completed successfully. 391 ballots were tallied.
- Ben Marks was reelected and Don Burns was elected to the Select Board and both have had the oath of office administered by Sue J. prior to tonight's meeting.
- Sue J. reported that she researched the cost of digitizing the rest of the land records (46 books with 200 documents per book). The total cost for scanning and re-indexing these records totals \$31,000. The outcome would be 24/7 availability of Cornwall land records back to 1981. Sue J. would like to see the completion of this project before she retires, as it would be very helpful to the next Town Clerk as well as anyone needing access to these records. She suggested that ARPA funds be used for this purpose.
- Sue J. said that the Capital Committee plans to meet to discuss options for the sand and salt shed.

ROAD COMMISSIONER'S REPORT - Brian Kemp and Steven Rheaume

- Bill has arrived for the work done on the excavator jointly owned by the Towns of Cornwall and

Shoreham

- Road crew has been focusing on pot holes and soft spots on gravel roads
- No time to do the tree work on Swamp Road, due to recent weather requiring focus on road maintenance.
- If needed, some sand remains in the shed.
- Sand and salt shed condition is a crisis situation.

OLD BUSINESS

• Discussion of current list of possible ARPA fund expenditures

The Board discussed items on the list including a recreational trail or open space, digitizing Cornwall land records, pre-school childcare, Town solar, Maple Broadband, and the sand and salt shed. Tanya B. presented information about an initiative to expand Otter Creek Childcare Center (that many Cornwall children attend) that would add 82 childcare slots and that is strongly financially supported by Middlebury College, but not fully, so there is a funding gap at this point in time.

• Discussion os Swamp Road bridge replacement process

The joint special meeting of Cornwall and Salisbury is scheduled for April 7 at 7 pm, during which the 3 options for replacing the Swamp Road bridge will be presented to the citizens of both towns. Ben M. plans to call the Town Clerk in Salisbury about the wording of the warning, so that the warning of the meeting in both towns is the same.
