## REPORT ON MAPLE BROADBAND - Magna Dodge

- Maple Broadband has received from Vermont Community Broadband Board (VCBB), grants of \$1.3 million and \$3.8 million for pre-construction costs, capacity building, and materials ordered after April 15. On April 18, Maple Broadband submitted a construction grant application to VCBB for 7.2 million, and has been answering all the follow up questions from VCBB about that application. At the end of this week, Maple Broadband will be sending out a Request for Proposals for construction work. Construction of the fiber network is planned to begin in August of 2022 in the Phase I area, with the first subscribers being able to sign up beginning in October.
- Act 71 established the Vermont Community Broadband Board (VCBB), charged with overseeing
  the build out of high speed internet throughout Vermont. Eligible providers can apply for grants
  from VCBB. Section 8082 of Act 71 defines an eligible provider as either "a Communication
  Union District (CUD), a small communications provider, or an internet service provider working in
  conjunction with a communications union district to expand broadband service to unserved and
  underserved locations as part of a plan to achieve universal broadband coverage in the district."
- OTELCO may be an eligible provider as defined above, however VCBB "shall not award a grant
  to an eligible provider who is not a communications union district unless the Board determines
  that the provider's universal service plan does not conflict with or undermine the universal
  service plan of an existing communications union district." Magna added that Maple Broadband
  will be making the case to VCBB that a grant should not be awarded to OTELCO for that reason,
  with evidence of how it would undermine the universal service plan of Maple Broadband.
- Magna D. advised that people take speed tests of their internet service and send them to VCBB, as the self-reporting of an internet provider on households that are served or underserved, may or may not be correct.

### TOWN CLERK / TOWN TREASURER'S REPORT - Sue Johnson

- Green Up Day is May 7. Sue J. will be at the Town Hall from 8 am -12 noon with supplies for the volunteers.
- At the Capital Committee meeting on May 10 at 7pm, Breadloaf will make a presentation about a a modified plan to replace the salt and sand shed.
- Tax payments are still coming in.
- The Town Office will be closed tomorrow, as Sue J. is teaching a class in Rutland for municipal treasurers.
- Interest in Town Clerk and Town Treasurer positions Sue J. has been contacted by a Cornwall resident who is interested and who would like to shadow Sue to learn more.
- Cott Systems contract for historical land records services was reviewed and discussed by the Board, as an appropriate use for American Rescue Plan Act (ARPA) funds. Contracted services from Cott Systems would add more 40 years (1981-2013) to the Cornwall land records now available online. John R. MOVED / Brian K. SECONDED a motion to authorize the signing of the contract with Cott Systems for a total of \$32,666 for historical land records services, using ARPA funds. *Motion passed* - 5 in favor, 0 opposed.

### **ROAD COMMISSIONER'S REPORT - Brian Kemp and Steven Rheaume**

- Stu Johnson has been helping with road grading and will now be training Steven R. on the grader.
- Road maintenance focused on gravel roads, hauling gravel.
- Steve R. is getting bids for the tree work on Swamp Road. Ben M. added that the shoulders on Swamp Road seem to be holding up well.
- Steve R. has been gathering information about options for solar speed signs and will bring brochures to the next meeting.
- Brian K. said that Mary Dodge contacted him with her concerns about debris in the large culvert on Route 74 that is preventing amphibians from traveling through it as part of their life cycle. Brian contacted the State to learn that no project is planned for Route 74 for the next 5 years.
- Several road signs in Cornwall have been stolen. Steve R. has contacted with State Police. Ben M. said Steven should repair and replace as needed.
- There have been issues with the alarm system at the Town Garage false alarms. Sue J. said that system is very old.

#### OLD BUSINESS

## • Swamp Road Bridge Replacement - discussion of polling to date

- Sue J. reported that there has been an almost 50% rate of return on the postcards so far, with only 2 cards that were returned as undeliverable, one card with nothing marked, and one card with 2 choices marked. Of the remaining cards returned to date, there were 47 voters who prefer a steel truss bridge, 140 voters who prefer a concrete span, and 261 who prefer a covered bridge. Sue also read the comments on the cards, which included concerns about vandalism or another fire, if a covered bridge was chosen.
- Paul Vaczy said that the Salisbury Select Board will be meeting on May 10 to discuss the results
  of polling in that town. Ben M. suggested that the next Cornwall Select Board meeting on May 17
  be a joint meeting with the Salisbury Board. Paul V. will call Ben M. next week to confirm. Ben
  M. also offered to attend the Salisbury meeting on May 10, if that would be helpful.

## • Discussion of and Possible Vote on Vermont Solar Fund Cornwall Solar Project Proposal

After discussion, John R. MOVED / Don B. SECONDED a motion to approve in principal an agreement and move forward with Ian Phair for a 23.25 Kw solar array to be financed by Mr. Phair that has a buy-out option anytime after 6.5 years. *Motion passed* - 4 in favor, 0 opposed, 1 abstained (Tanya Byker).
