Thence S 87° 21' 49" W 697.49 feet along the northerly line of lands now or formerly Palmer to corner "10," a point in the approximate centerline of the private roadway known as Bardon Drive, being the southwesterly corner line of Lot 1;

Thence along the easterly line of Lot 3, following the centerline of Bardon Drive as it gradually curves to the left, 927 feet, more or less, to corner "19," a point at the northwesterly corner of Lot 1;

Thence S 85° 12' 05" E 348.73 feet along the southerly line of Lot 2 to corner "14," the point of beginning.

The herein conveyed Lot 1, together with Lots 2 and 3 as shown on the Plat, is **subject to and benefited by** the following restrictive covenants, which shall run with the land and be enforceable by the owners of Lots 1, 2, and 3 and their heirs, successors and assigns:

- a. Each Lot shall be developed with no more than one single-family residence, together with one accessory dwelling if authorized by applicable State and municipal laws and regulations.
- b. No Lot shall be further subdivided without approval of the other Lot Owners and receipt of all required state and municipal permits. A boundary line adjustment between two Lots that does not create any additional parcels shall not be considered a subdivision within the meaning of this covenant.
- c. No single- or double-wide mobile homes shall be constructed on any Lot.
- d. Campers, motor homes, or similar vehicles may be parked or stored on a Lot, but shall not be occupied for residential purposes for more than 14 days within any calendar year.
- e. No unregistered, inoperative, or "junk" vehicles shall be permitted on any Lot unless stored out of sight inside a garage or similar structure.

The herein conveyed Lot 1 is **subject to and benefited by** an Easement and Road Maintenance Agreement between Rose Torrey, Trustee of the M. Hartley MacFadden Trust, and Michael P. Palmer and Gisela Palmer, dated _______, 2022, and recorded in Book _____ at Page ____ of the Cornwall Land Records. Said Agreement defines the terms of easements and maintenance obligations for access and utility service serving Lots 1 through 3 as well as lands of Palmer located southerly of Lots 1 and 3.

Lot 1 is further **subject to and benefited by** easements and governmental permits of record, provided that nothing in this paragraph shall reinstate obligations previously extinguished by the Vermont Marketable Record Title Act. Without limiting the foregoing, the property is subject to and/or benefited by the following:

1. The 50' wide easement and right of way over the private roadway known as Bardon Drive, as shown on the Plat and as more particularly described in the above-referenced Easement and Road Maintenance Agreement;

same against all lawful claims whatever, except as aforesaid.
